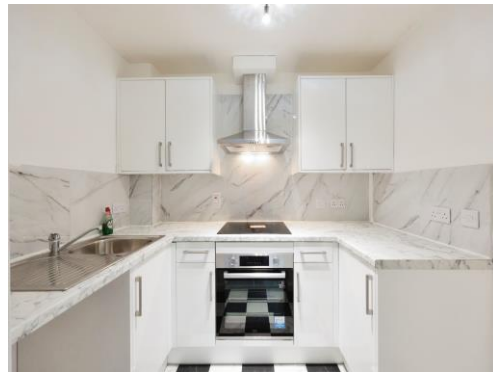

Property Description

Ground floor apartment offered to the market with no onward chain. Comprising open plan reception room / kitchen, with direct access to the communal garden, main bedroom with dual aspect windows, second bedroom and bathroom with shower over bath. 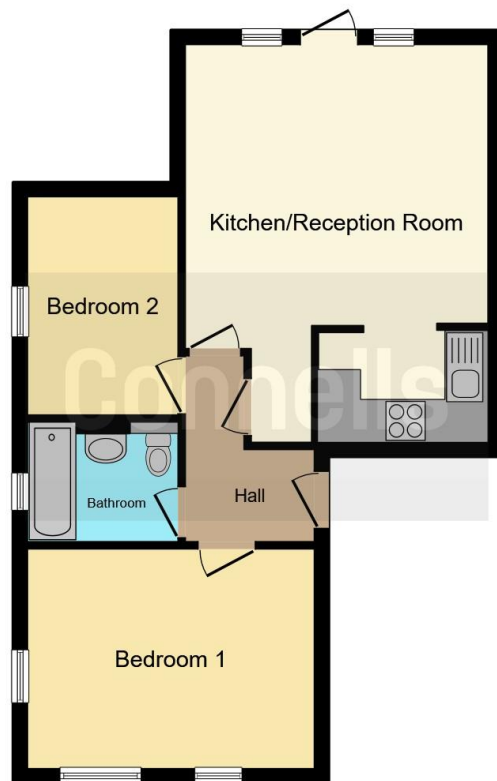
