Allen and Harris are proud to present this delightful detached four-bedroom family residence with origins back to the 17th Century, set in grounds approaching a 1/4 of an acre. The original part of the property retains much of its character with exposed ceiling and wall beams. The property offers further scope for enlargement as there is currently a separate studio which was formerly used as a hair salon which could easily be incorporated in the main accommodation or is suitable for use as a professional business premises subject to consents. Additionally, there is a detached double garage with large open plan room over which again, subject to the necessary consents could be converted to provide annexe accommodation. The property is approached via an entrance hall which has period exposed beams to the walls and gives access to the downstairs cloakroom, a very generous sitting room measuring in excess of 22ft in length, again with exposed beams and period

features. There is a separate dining room with exposed beams to the ceiling.


