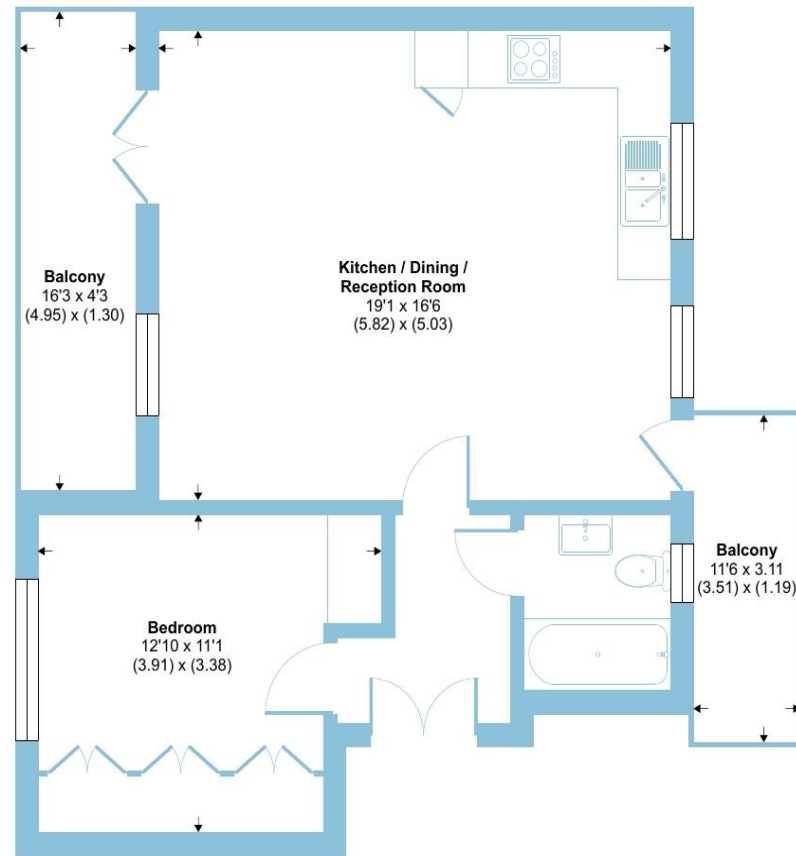




Somerset Lodge, Courtlands, Maidenhead, SL6
