Entrance Hall

The entrance hall has doors leading to the living room, dining room, utility room, kitchen, basement and has two radiators.

Lounge

The lounge has a window to the front aspect of the property with shutters, fireplace wood burner and radiator.

Dining Room

13' max x 12' 4" (3.96m max x 3.76m)

The dining room has a window to the front aspect of the property with shutters, feature fire place and a radiator.

Kitchen

11' 7" max x 11' 4" (3.53m max x 3.45m)

The kitchen is a fitted kitchen with a range of wall and base units, window to the rear aspect of the property and door to the rear. The room offers a 1 & 1/2 bowl sink/drainers, butcher block work surfaces, plumbing for dish washer, space for fridge/freezer, radiator and space for range oven.
