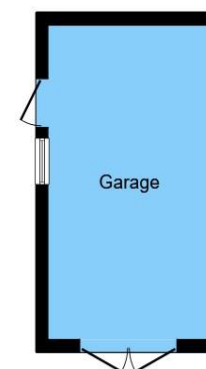




Ground Floor
