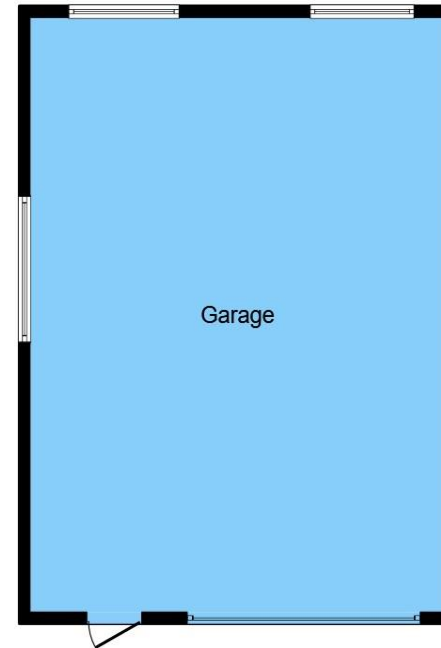
## **Willow Grove, Trowbridge**
