Lounge

18' 1" \times 13' 10" (5.51m x 4.22m) Has exposed beams and exposed stone walls, central heating radiator, timber flooring, multi fuel stove with timber mantle over, wall lights, corner TV unit, open plan staircase to first floor accommodation.

Kitchen & Dining Area

27' 3" x 14' 3" (8.31m x 4.34m)

With barn style door to the side, tiling, range of wall, base and matching drawer units, room for a fridge freezer, electric aga style cooker, Belfast sink, windows to the front and side, wall cutlery holder, worktops, room for a dishwasher, two central heating radiators, wall lights, exposed beams and beautiful views of the garden from the kitchen area. Beyond the kitchen is an extended dining area.

Utility Room

19' 11" x 13' 5" (6.07m x 4.09m)

Having central heating radiator, tiling, wall and base units, Belfast sink, window to the side, door to the front, plumbing for a washing machine, downlights, enclosed central heating boiler, worktops, further appliance space.

Guest Cloakroom

Having tiled flooring, w.c., wash hand basin with splashback tiles, central heating radiator, downlights.

Landing Area

Having central heating radiator, wall lights, exposed beams, downlights, window to the side elevation.

Master Bedroom

14' 5" x 13' 3" (4.39m x 4.04m) Includes stone walls, exposed beams, central heating radiator, downlights, two windows to the front elevation.

Bedroom Two

11' 11" x 11' 2" (3.63m x 3.40m) The second bedroom has timber flooring, exposed beams, downlights, central heating radiator, velux window, french doors to the personal balcony which consists of a hard land scaped area, metal railings and and a metal personal gate, views overlooking trees, greenery and the River Dove.

Bedroom Three

11' 2" x 9' 5" (3.40m x 2.87m) Having central heating radiator, window to the side elevation, exposed beams, downlights, wardrobe.

Bathroom

10' 3" x 8' 9" (3.12m x 2.67m) Holds a corner bath, mains shower cubicle, laminate flooring, heated towel rail, wash vanity unit, window to the front elevation, part tiled walls, w.c., cupboards, exposed beams.

Shower Room

7' 11" x 5' 10" (2.41m x 1.78m) Includes mains shower cubicle, laminate flooring, part tiled walls, exposed beams, downlights, w.c., wash hand basin.
