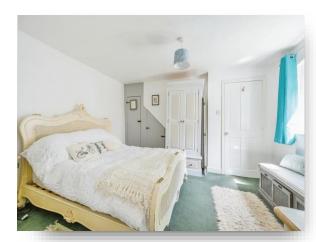












Entrance Hall

As you enter the property you are greeted with the entrance to the two downstairs bedrooms and the staircase to the first floor.

Living/Dining Area

22' 9" x 14' (6.93m x 4.27m)

The upstairs living area consists of two sky-lights to the front elevation and an electric fireplace with a spacious area for a sofa, dining table and chairs. You are provided with access through to the kitchen area.

Kitchen

12' 9" x 8' 11" (3.89m x 2.72m)

The Kitchen area is situated at the side elevation of the property with a double glazed window overlooking the town centre. Within the kitchen you have a fridge, dishwasher, freezer and integrated hob/oven with a generous amount of cupboard/drawer space.

Bedroom One

The first bedroom provides a double glazed window to the front elevation, under stair storage space and an en-suite.

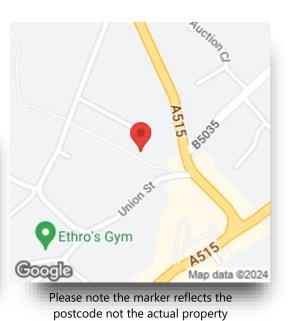
