First Floor Reception Hall:

32' 10" x 4' 5" (10.01m x 1.35m) Front window; radiator; ceiling cornice; staircase to second floor.

Sitting Room:

19' x 20' (5.79m x 6.10m) Dual aspect with side and rear windows with breathtaking far reaching views; radiator; cast iron multi-fuel stove with stone hearth and decorative stone surround; wall light points to each recess; ceiling cornice.

Dining Kitchen:
