Kitchen Dining

18' x 14' 1" (5.49m x 4.29m)

This superb open plan kitchen and dining area is accessed via a traditional stable door and is fitted with range of wall and base units with roll top work surfaces, splashback tiling and a stainless-steel sink and drainer. There is a central heating radiator, spotlights, tiled flooring, dual aspect double glazed windows and stairs leading to the first floor.

Downstairs Bathroom

5' 11" x 5' 5" (1.80m x 1.65m)

A wooden panelled door with thumb nail latch opens into the bathroom which comprises of a bath with a shower above, a wash hand basin and a WC. Splashback tiling, underfloor heating and ceiling with spotlights.

Living/Bedroom Area

18' x 14' 1" (5.49m x 4.29m)

Leading from the stairs there is a delightful open plan living/bedroom area, which includes dual aspect views from every angle through double glazed windows. The focal point of the room is the log burning stove, complete with quarry tiled flooring. There are beams to the ceiling, a central heating radiator, spotlights and carpeted flooring.
