Entrance Hallway

Entering the property through the entrance doorway, with a window to the front elevation, door leading to the kitchen and stairs to the first floor.

Dining Room

Window to the rear elevation, central heating radiator, laminate flooring, door leading to the kitchen and archway leading to the lounge.

Lounge

With window to the front elevation, carpeted flooring, door leading to the entrance hallway and archway leading to the dining room.

Kitchen

Fitted kitchen comprising of stainless steel sink set in a base unit, further base and wall units, pantry, laminate flooring, and space and plumbing for washing machine. With doors leading to the dining room, entrance hallway and rear lobby, and window to the rear elevation.

Rear Lobby

With access to the downstairs w/c, kitchen, and external door to the driveway and rear garden. Also housing a storage cupboard.

W/C

Window to the side elevation, low level w/c.

Bedroom One

Double bedroom with window to the front and fitted storage cupboard.

Bedroom Two

Double bedroom with fitted storage cupboard, window to the rear, and radiator.

Bedroom Three

Window to the front.

Wc

Window to the rear, low level w/c.

Shower Room

Window to the rear, wash hand basin, walk in shower, partial tiling.

External

To the front of the property there is off road parking for multiple vehicles, in addition to the garage, laid to lawn frontage bordered by mature shrubbery. To the rear, the extensive, private and enclosed garden has been carefully nurtured, with mature plants, shrubbery and trees, and has outdoor storage structures, in the form of sheds and a greenhouse.

Conditions Of Sale

The Conditions of Sale will be deposited at the offices of the auctioneers and vendor's solicitors seven days prior to sale and the purchaser shall be deemed to have knowledge of the same whether inspected or not. Guide And Reserve Prices


