Entered through the stunning communal areas and via a lift, this is a two bedroom, two bathroom first floor apartment, presented in an immaculate condition, with lots of natural light. The property comprises of a large open plan kitchen/ living room with space for entertaining, two double bedrooms, one with en suite and a very generous family bathroom with bathtub and overhead shower. There is lots of storage throughout.

The property has been finished to a very high specification, boasting engineered oak flooring, an Italian designer kitchen with integrated Bosch appliances, wireless audio system and inlaid speakers, video entry and underfloor heating in the bathrooms.

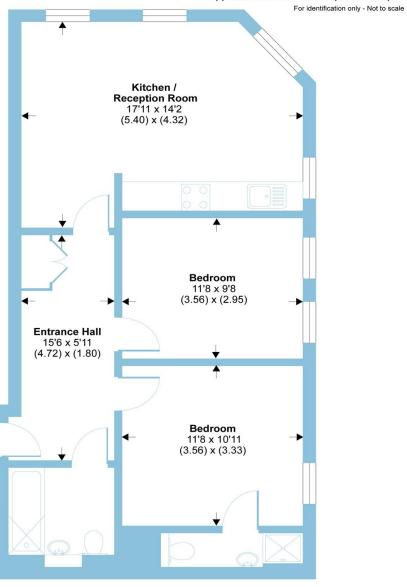
