A delightful one bedroom apartment located on the first floor of a period conversion. Situated close to Wandsworth Common and Earlsfield Station.

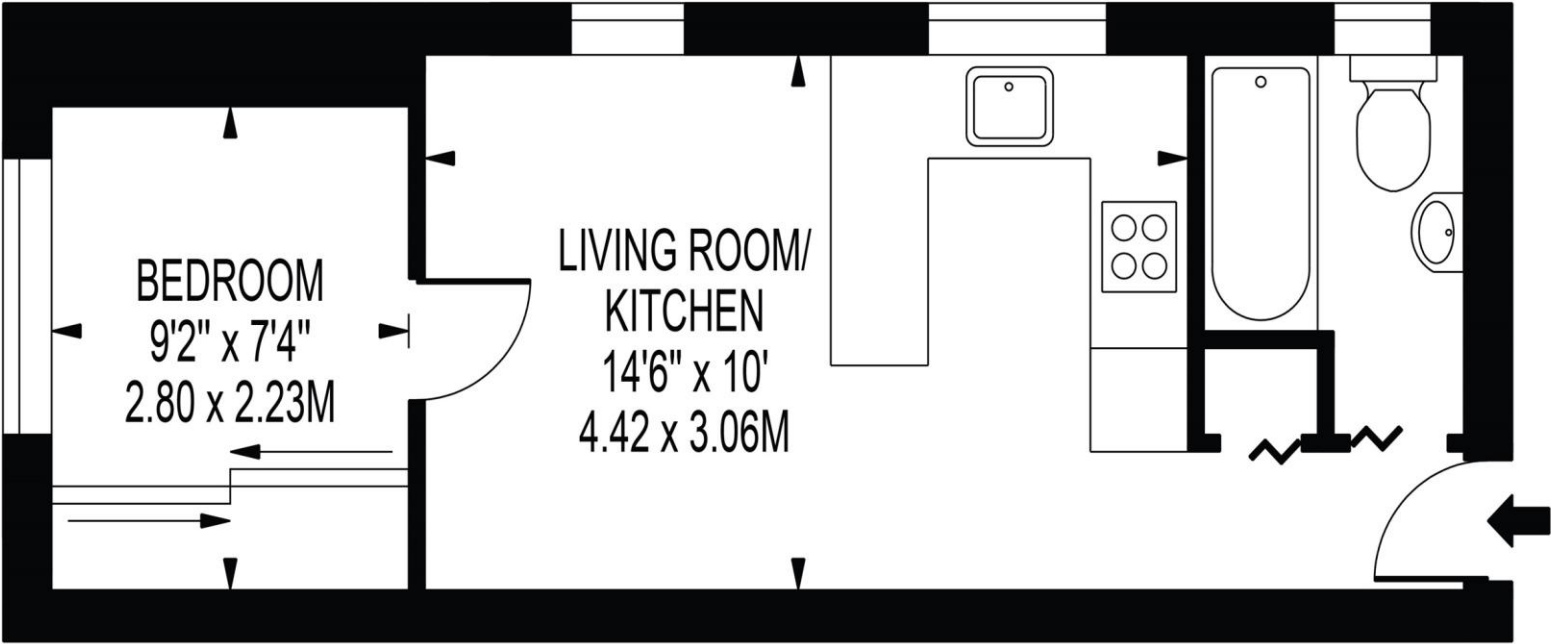
