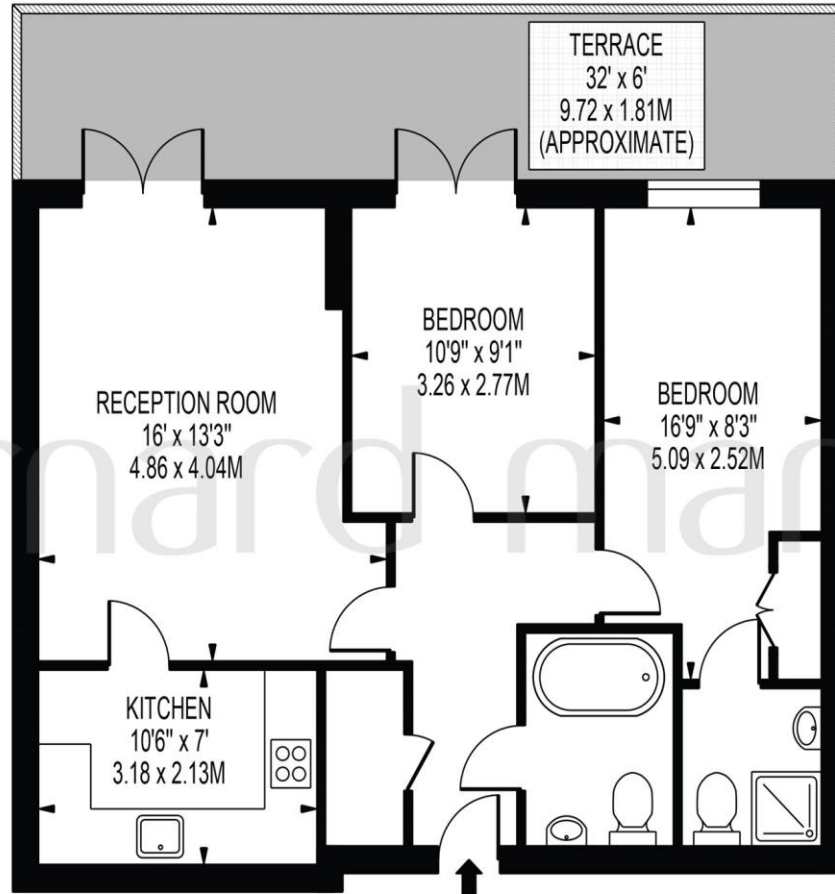
Wey House is nicely situated in a picturesque location with the Grand Union Village, with views of the canal as well as a large open space for residents overlooking the Marina.
