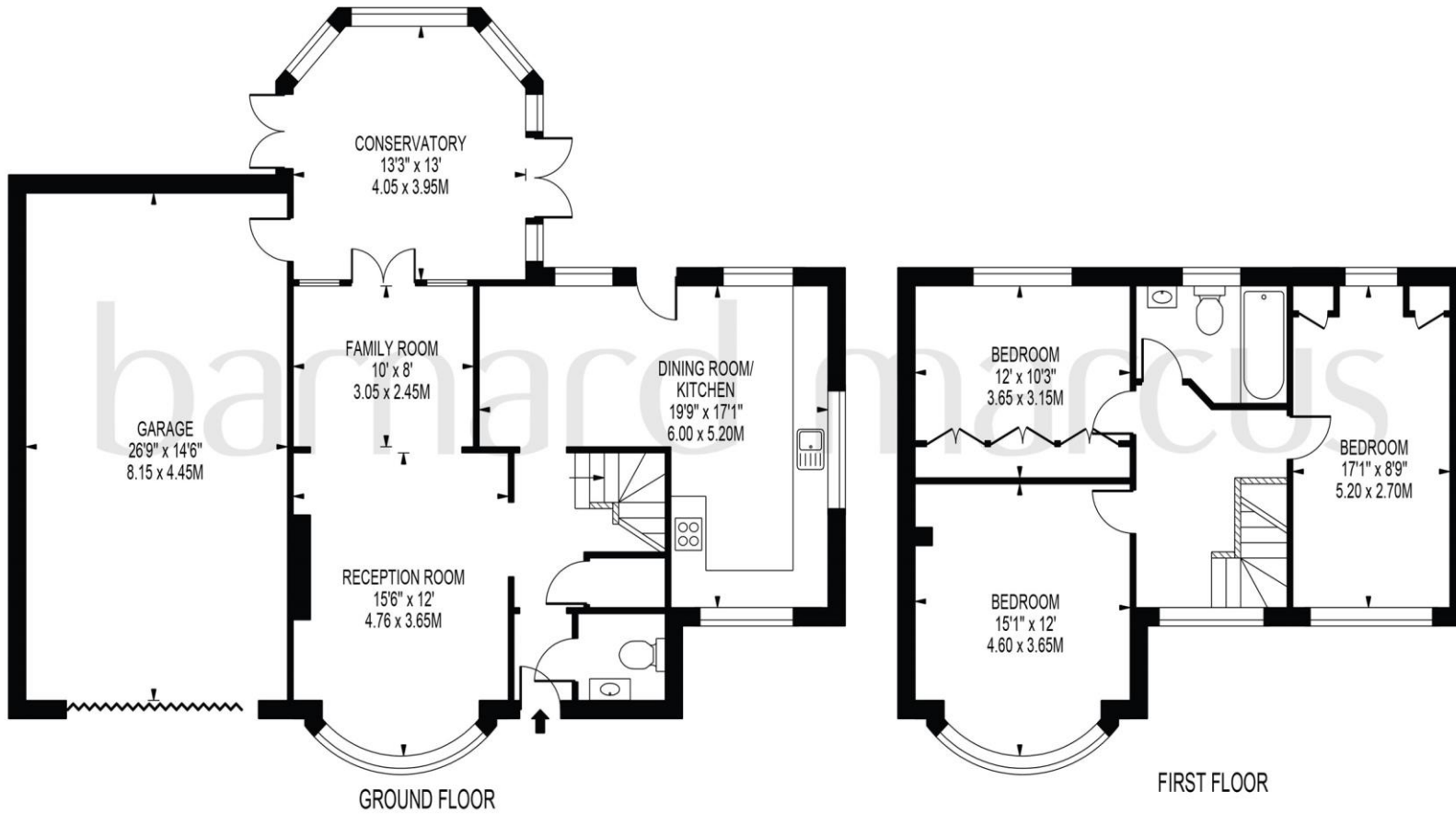
Elizabeth Way is located in the quiet residential area of the Hanworth Park development providing easy access to the A316, M3, M25 and excellent local transport links.
