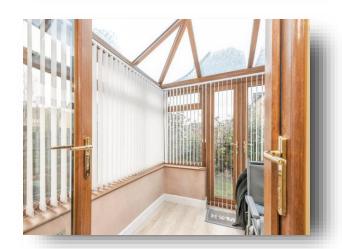
Located in Bradford is this three bedroom property, featuring a conservatory and front and rear gardens. Ideal for first time buyers. With easy access to local shops and major transport links.

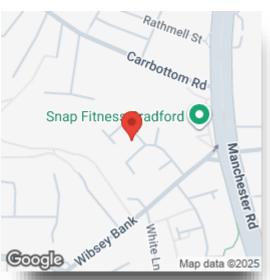
