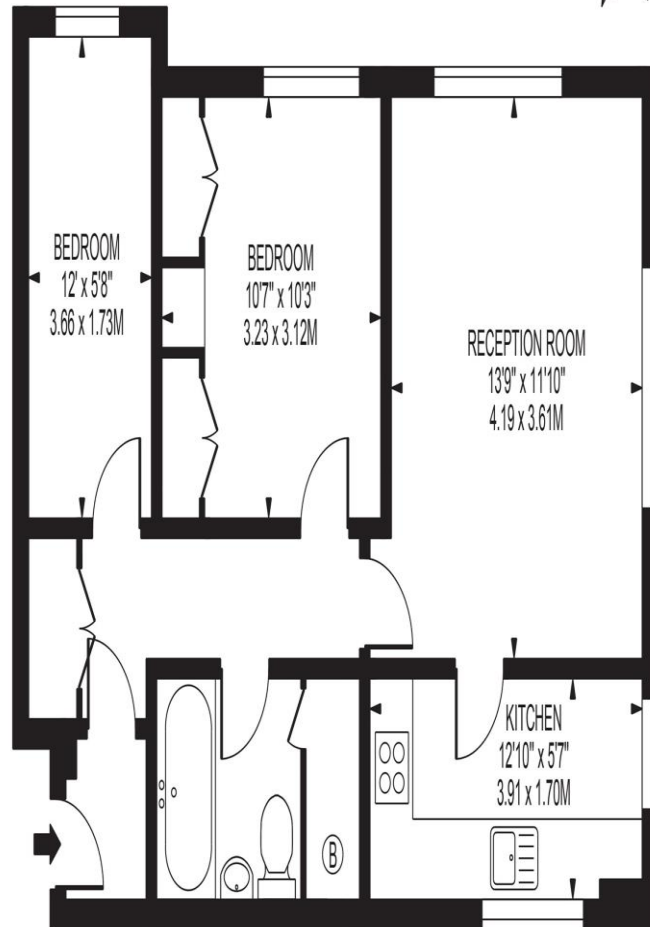
With the Tandem Centre local, this is perfect opportunity to shop & have a chill coffee or tea in Starbucks after.
