Entrance Hall

With uPVC front door, with staircase ahead and door to the lounge.

Lounge

With uPVC window to the front aspect, wood laminate flooring, under-stairs storage cupboard, a wall mounted radiator and door to the kitchen/diner.

Kitchen/Diner

With uPVC window to the rear and side aspect, ceramic tiled flooring, modern style fully fitted kitchen with floor- toceiling wall and base units, central island breakfast bar, a mid-height integrated oven, separate electric ceramic hob with extractor above, sink, drainer and mixer tap, a modern style vertical wall mounted radiator, space for double fridge freezer and washing machine and uPVC French doors to the rear aspect leading to the conservatory.
