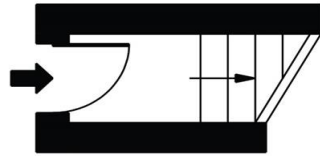
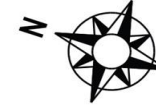
Currently comprising a modern and fully integrated kitchen, reception room, shower room and three bedrooms.

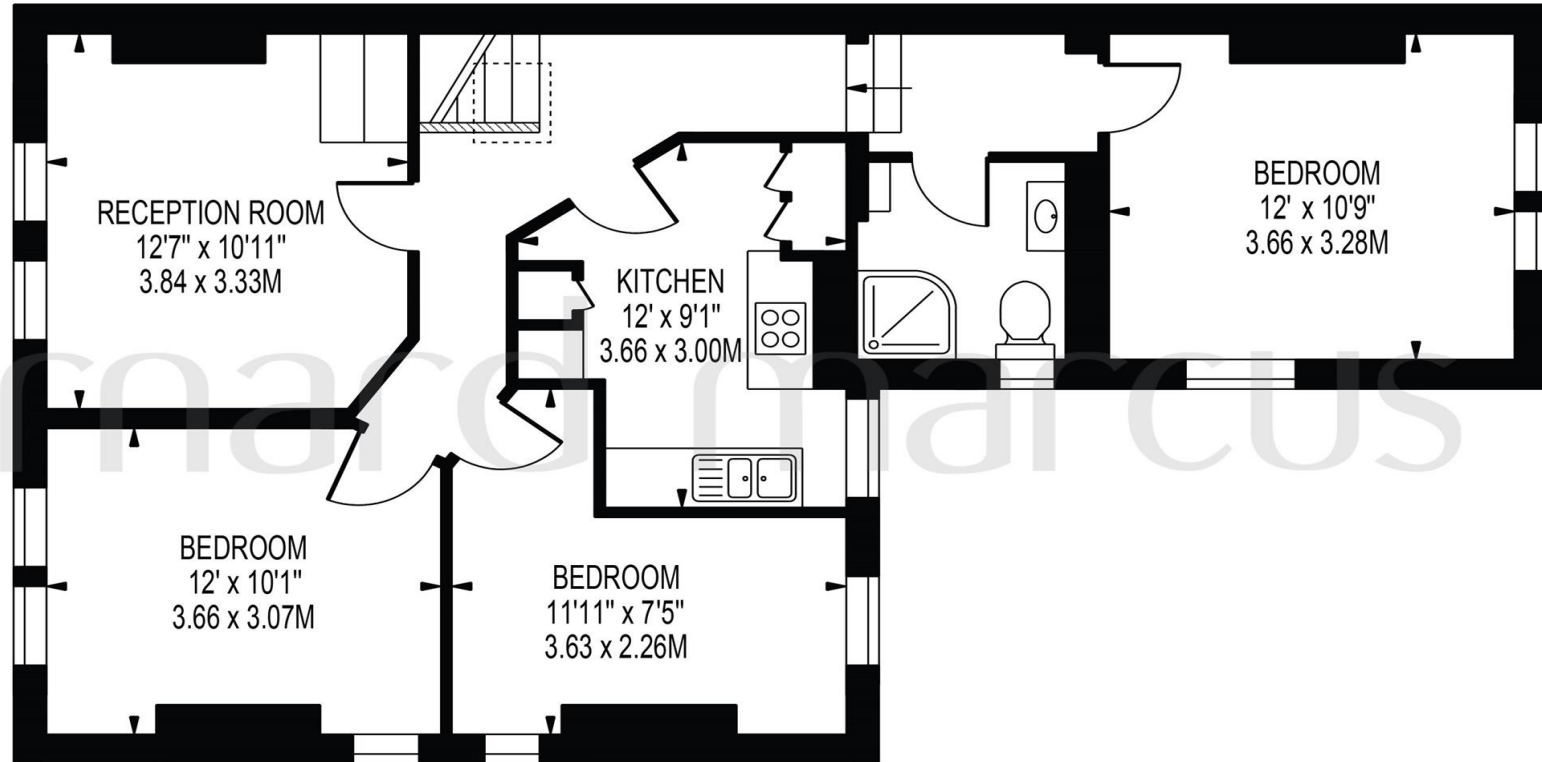
