This apartment is located in the fabulous development of Park Point on Henderson Road, comprising of one-bedroom, open plan kitchen/living room, bathroom and a private balcony.

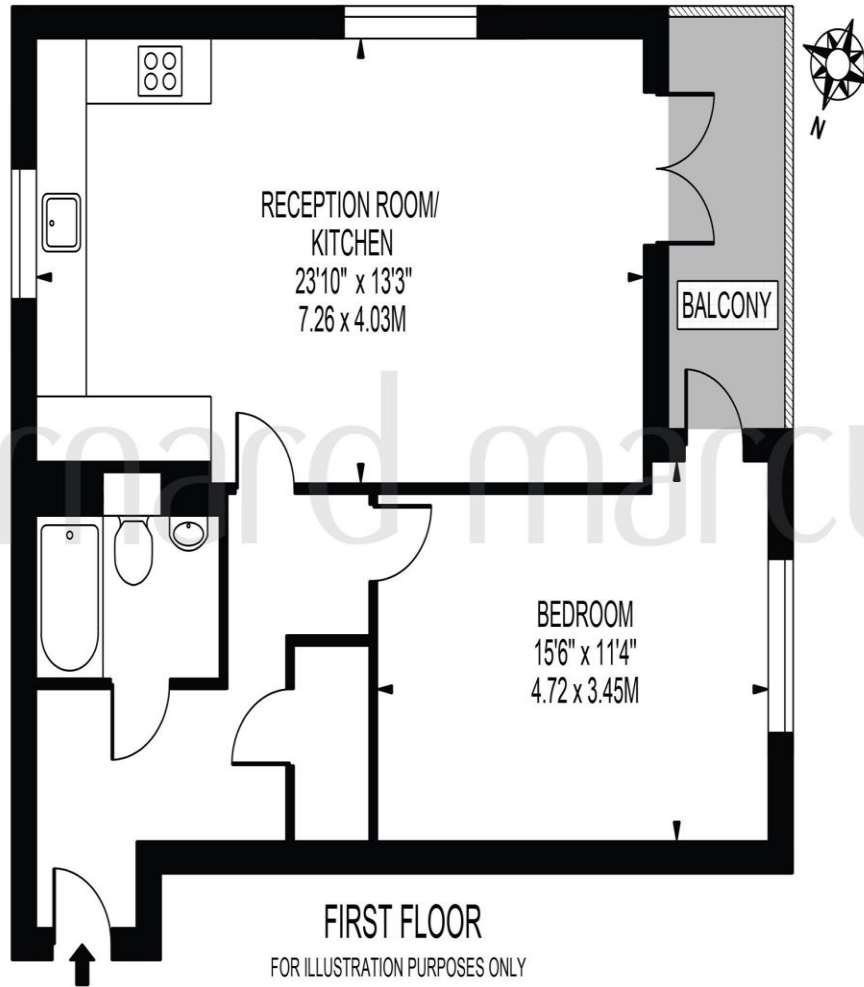
Park Point is a small development of just nine one-, two- and three-bedroom apartments and maisonettes with some overlooking the beautiful parkland which runs adjacent to the development.
