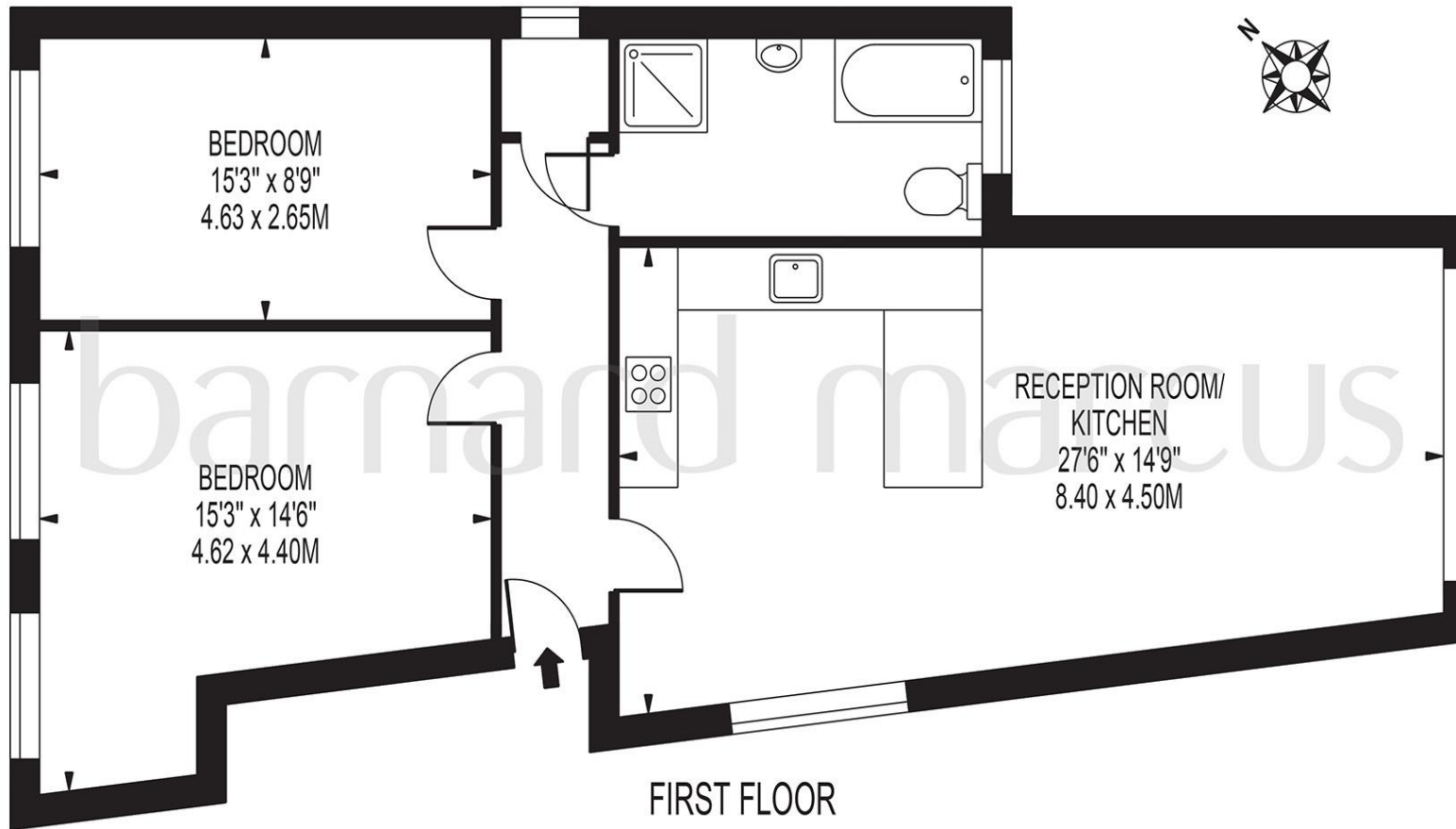
An additional benefit is the property is offered without chain.
