Entrance Porch

Built of a mix of brick and Upvc construction with double-glazed windows to the front and side. Double doors to the side and a door to the entrance hall.

Entrance Hall

Stairs to the first floor and under stairs storage cupboard. Doors to the cloakroom, kitchen, dining room and lounge.

Cloakroom

Wash hand basin and low-level WC. Radiator and double-glazed obscured window to the rear.

Lounge

19' 9" x 11' 3" (6.02m x 3.43m)
Gas fireplace, 2 radiators and double-glazed window to the front. Double-glazed Patio doors to the rear.

Conservatory

19' 7" x 8' 3" (5.97m x 2.51m)
Conservatory of Upvc construction with double-glazed windows to the rear and side. Door to the kitchen and double-glazed door leading out to the garden.

Kitchen

14' 6" x 9' 9" (4.42m x 2.97m)
Fitted with a mix of wall and base units with work surface over, 1.5 bowl stainless steel sink with drainer, electric double oven and gas hob with a chimney style extractor fan over. Space for a washing machine and an under counter fridge. Central heating boiler and a freestanding butchers block. Double-glazed window to the rear and door to the conservatory. Opens into the dining room.

Dining Room

11' 2" x 9' 3" (3.40m x 2.82m)
Radiator and double-glazed window to the front. Door to the entrance hall and opens into the kitchen.

First Floor Landing

Stairs from the ground floor and 2 hatches, each with a fitted ladder, giving access to a boarded loft.

Bedroom One

14' 6" x 11' 1" (4.42m x 3.38m)
Built-in wardrobe, radiator and 2 double-glazed windows to the rear.

En-Suite

Wash hand basin, low-level WC and shower cubicle. Double-glazed obscured window to the rear.

Bedroom Two

11' 6" x 9' 9" (3.51m x 2.97m)
Built-in wardrobes, radiator and double-glazed window to the front

Bedroom Three

11' 6" x 10' 5" (3.51m x 3.17m)
.Built-in wardrobes, radiator and double-glazed window to the front.

Bedroom Four

9' 7" x 6' 4" (2.92m x 1.93m)
Radiator and double-glazed window to the rear.

Bathroom

Fully tiled with wash hand basin, low-level WC and bath with shower over. Heated towel rail and double-glazed obscured window to the rear.

Outside Garage

Detached garage with 2 electric doors.

Front Garden

Laid to lawn with mature shrubs and a driveway in front of the garage providing off-road parking.

Rear Garden

Enclosed by panel fencing the garden is laid to lawn with mature shrubs borders.
