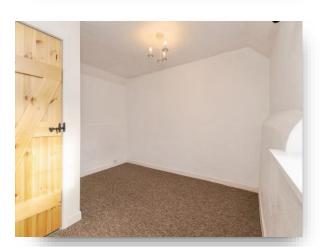












Lounge

Bedroom One

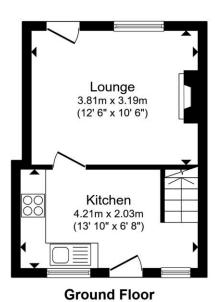

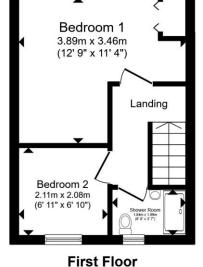

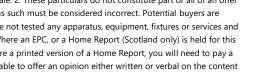
