#### **Entrance Hall**

Entered via the front door, a radiator, under stairs storage cupboard housing the wall mounted gas fired boiler.

### Lounge

 $11' 7" \times 13' 1"$  into bay (  $3.53m \times 3.99m$  into bay ) Double glazed bay window to the front, open fireplace and radiator.

### **Dining Room**

11' 6" x 10' 8" ( 3.51m x 3.25m )

Double glazed window to the rear, feature fireplace and radiator.

#### Kitchen

8' 8" x 8' 6" ( 2.64m x 2.59m )

Fitted with a range of matching wall and base units, one and half sink basin with mixer tap and drainer, electric hob and oven, space for a washing machine and under counter fridge. Double doors to utility area.
