

OUTSIDE

The property has the benefit of a parking space located in the adjoining car park. There is a good- sized rear garden with lawn, patio and shed.

The property is a shared ownership property. 25% is available to purchase. The remaining share will be retained by Home Group Rent is paid on the unowned share of the property. Based on 25% ownership the rent and service charge payment is £629.32 per month.

The property is long leasehold, with an original lease of 125 years from 2020.

You may purchase further shares of the property at any time, in this property up to 100%.


Animals or birds may only be kept at the property with written permission from the landlord, in the form of a revocable license at a cost of £125 plus VAT.
