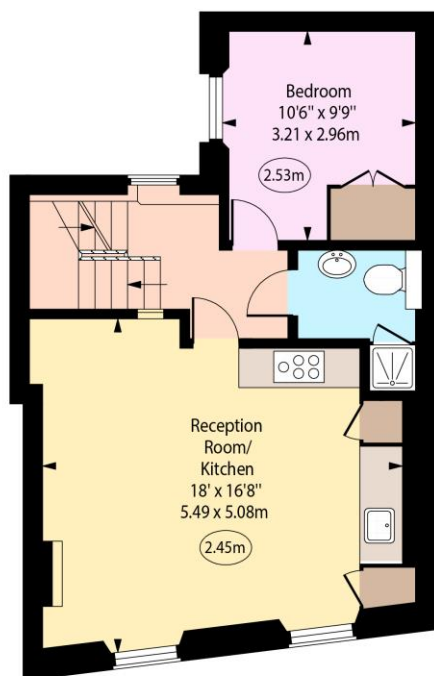

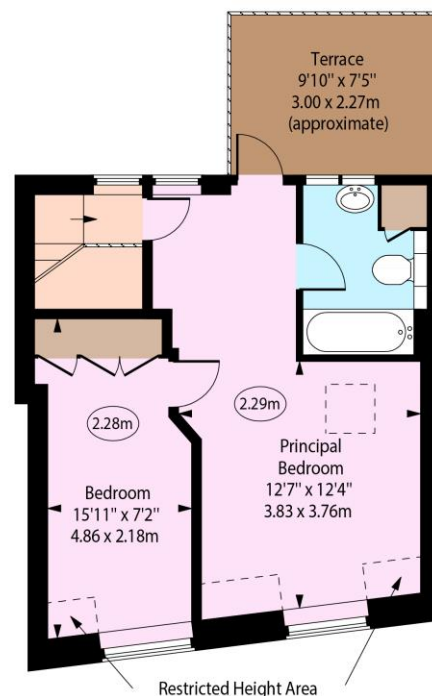
Second Floor
