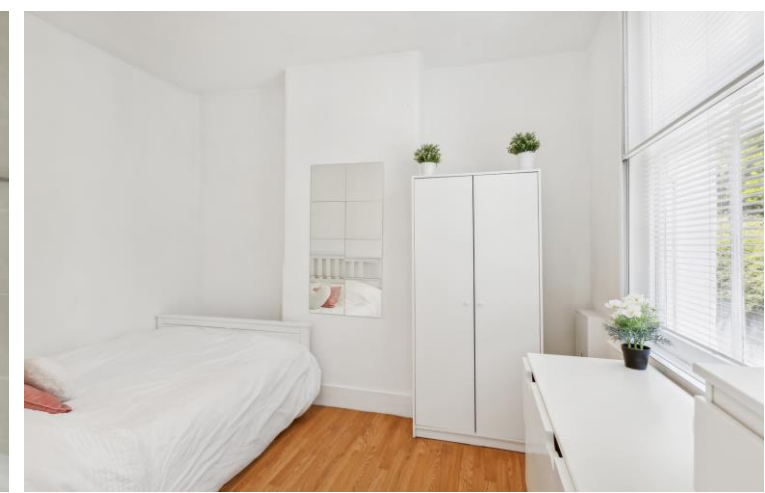

A beautiful mews house set over 1400 sqft with private garage situated on picturesque cobbles mews.

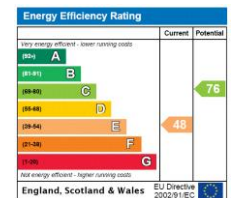
The house is wonderfully laid out with a large open plan kitchen reception room that benefits from excellent natural light. There is also a separate study and large garage on the ground floor.

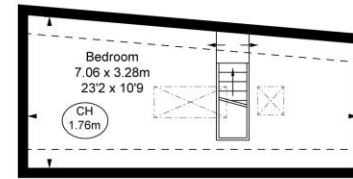

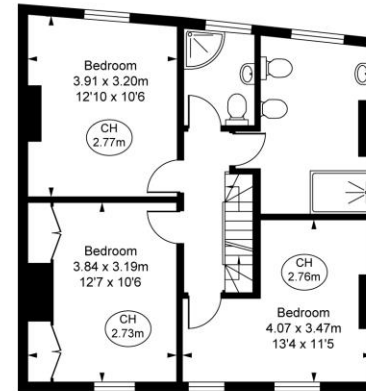
