Positioned on the fourth floor with both lift and porter, the property combines period charm with the convenience of modern lateral living.

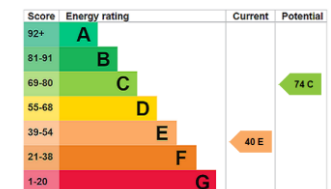
