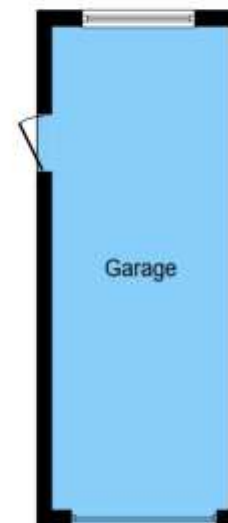




Ground Floor
