Bradford Interchange and Forster Square Retail Park are within the area, making transport links and shopping more convenient. As well as a gym, cinema, bowling and various restaurants.







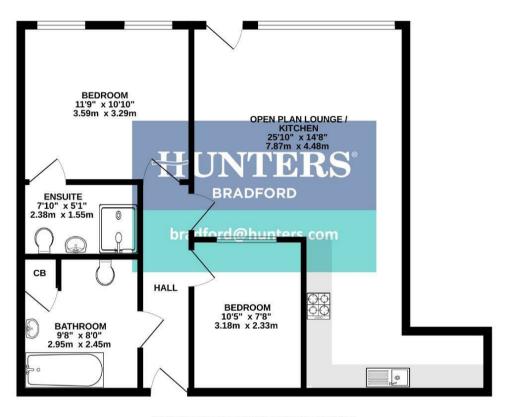

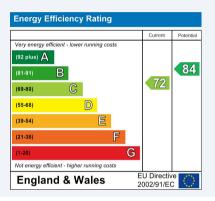
