The fields are predominantly Grade 2 as categorised by the Land Classification of England & Wales. The soil type is from the Downholland 1 series being described as "Deep stoneless humose clayey soils, calcerous in places" by the Soil Survey of England & Wales.

There are two small traditional storage sheds on the land.

### **LOCATION**

The land comprises two parcels of arable land one mile south of the town of Crowland. A sign board will be erected.


