LOCATION

DESCRIPTION

This single storey annex has recently undergone a complete renovation, making it an attractive and comfortable place to call home. The interior is modern yet charming, with rustic features such as exposed stone walls and wooden ceiling beams. With vinyl flooring and neutral decoration throughout, the annex also benefits from plenty of natural light that floods in, creating a warm and inviting atmosphere.


