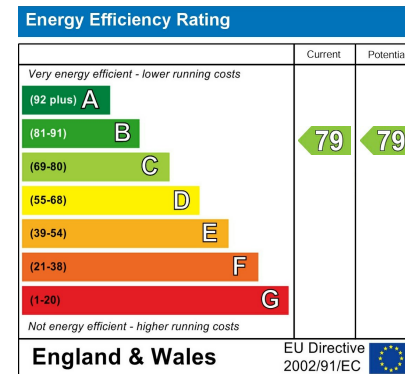
Floor Plan
