Positioned on an attractive corner plot, this extended detached bungalow offers well proportioned and flexible accommodation which has been well maintained and updated by the current vendor. A good sized hallway gives access to the lounge with open fire place. The kitchen breakfast room has been refitted giving ample storage and work surface area with built in hob and oven. A large side porch runs the depth of the property and gives plenty of storage. A refitted wet room is adjacent to the main bedroom which has built in wardrobes. A separate dining room also has built in storage and gives access to bedroom 2. The property has replacement UPVC double glazing and barge boards for ease of maintenance. The property sits on a wide corner plot with driveway giving off road parking and leads to large detached garage. The gardens are very well maintained and looked after, with lawns and shrubs to the front and gated access to the rear garden which is again well maintained with specimen trees and shrubs with patio area and raised borders, all enclosed giving a high degree of privacy.




