Located towards the end of a no through road this predominantly brick built period home under a slate roof is offered with no chain. Extended to provide additional ground floor accommodation the property is well presented throughout with oil central heating and many of the windows replaced with double glazed units. The property retains many period features including a Rayburn to the kitchen dining room with a larder off, open dressed stone walling and a multi fuel burner to the living room which can heat the hot water if required. The property is enhanced by Amtico flooring to the reception hall areas, kitchen dining room and the extended sun room with its vaulted ceiling and views over the lovely garden. There is also plenty of storage cupboards and bespoke units made from Belize hardwood along with air conditioning units to the master bedroom and the sun room. In brief the accommodation comprises, reception hall with built in cloaks cupboards and inner hall, utility, cloakroom, kitchen dining room, larder, sun room and L shaped living room. To the first floor the configuration is ideal for a growing family with a teenager or a dependent relative with a two way landing with one side providing master suite with walk through dressing room, bedroom area and an ensuite cloakroom, further double bedroom and refitted shower room. To the other side is a further 2 bedrooms, one currently used as a study, and a further bathroom. The property is gable end onto Mill Lane with an integral oversized garage and double gates to the side giving further access to the extensive private gardens with cabin/summer house, patio areas and variety of shrubs, roses and fruit trees. In all the plot extends to 0.28 acres with a south south east aspect and backs onto open fields.

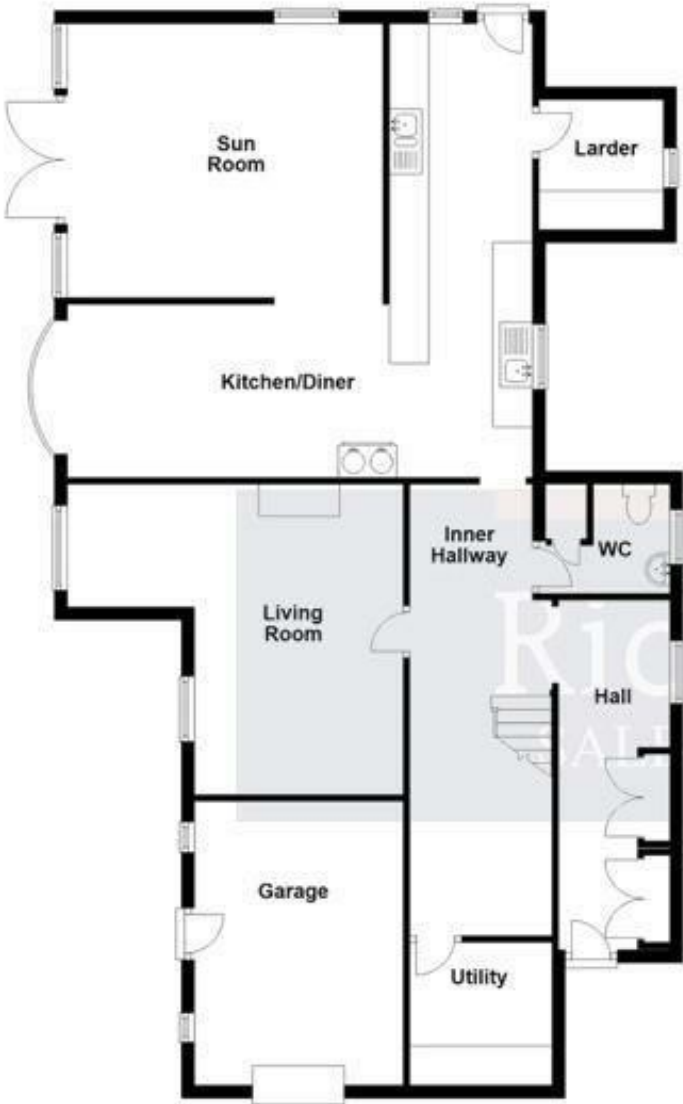




Floor Plan

Approx. 122.9 sq. metres (1323.0 sq. feet)

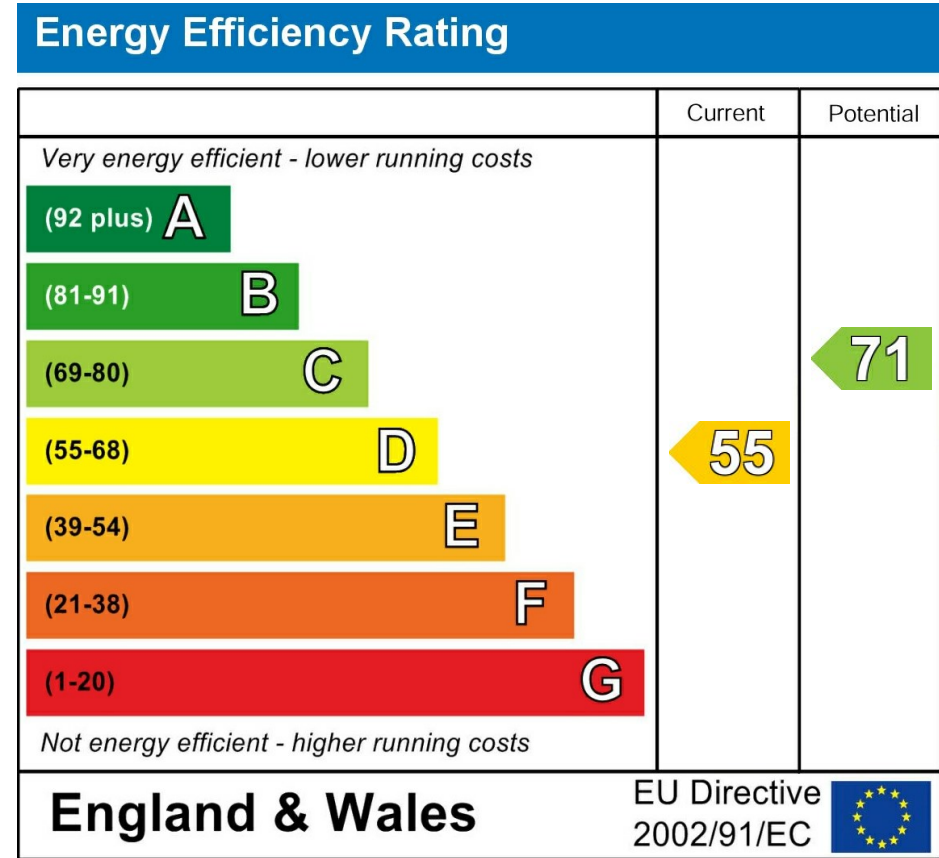


First Floor
