Calling all first time buyers to this great opportunity to own 40% shared ownership modern mid terrace property in the sought after village of Barnack. Offering well maintained and presented accommodation with reception hall with stairs to the first floor and doorway to the good sized living room with feature fireplace. The kitchen diner has plenty of room for table and chairs and is fitted with a range of base and eye level storage cupboards with work surface area between incorporating built in hob, oven and extractor fan while providing space for washing machine and dishwasher. A useful rear lobby gives access to the garden and also the downstairs cloakroom/WC. To the first floor are 2 generous double bedrooms with the master having built in storage and the bathroom has a shower over the bath. The loft has also been boarded for additional storage. There is a small front garden area. The rear garden has a lovely westerly aspect with a paved terrace leading onto lawns with raised beds and borders and pathway leading to a useful insulated shed with power connected and so offers scope to use as an office/workshop, and a smaller garden shed. The whole area is enclosed by fencing giving a good degree of privacy with a private gate leading to the pathway giving access to the allocated parking which is to the left of the property and accessed beneath a coach house. An additional benefit is the installation of heat recovery fans to the kitchen and bathroom as well as the Photovoltaic Solar Panels connected to a thermal hot water system for heating the hot water and potentially reducing the running costs.

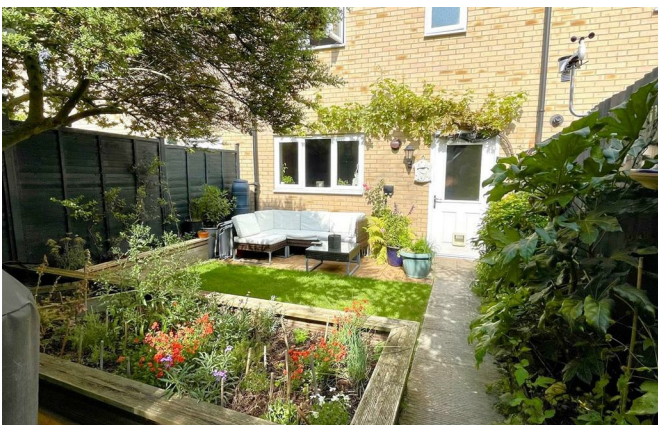

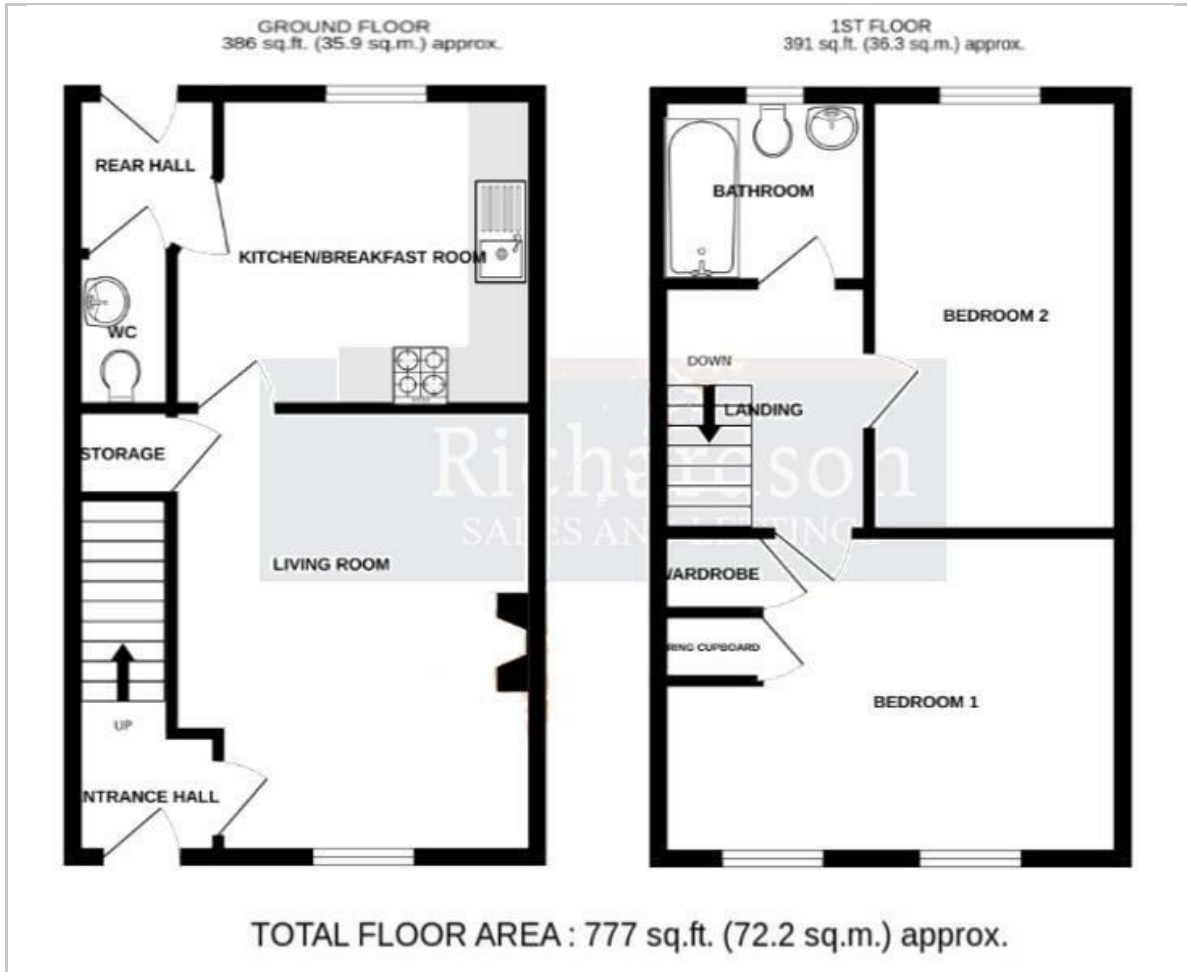

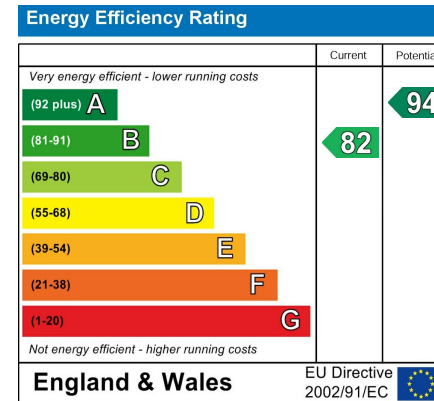
Floor Plan
