An attractive end of terrace stone cottage, which is in need of complete modernisation on a sizable plot with detached double garage, situated in the small village of Little Casterton approximately 2 miles north of Stamford town centre in the country of Rutland. A single storey extension to the rear provides a bathroom and lobby area. The accommodation comprises small reception hall, living room with open fire facility, kitchen, lobby and bathroom. To the first floor there are 3 bedrooms. The property currently has electric storage heaters and some windows have been replaced. Externally there is a driveway to the side leading to a detached double garage with power & water connected, and out house. A surprising large garden is to the rear and backs onto open land.

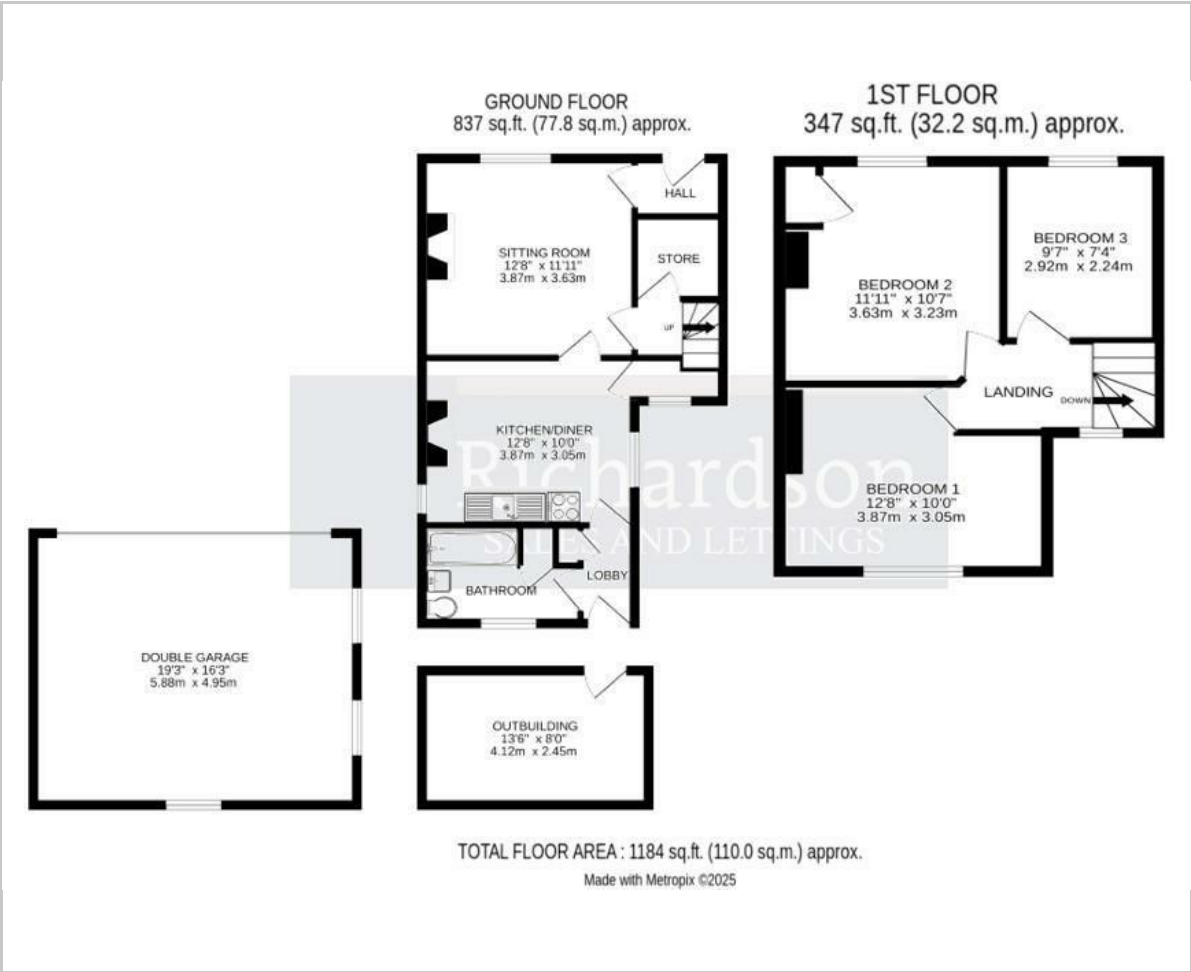
The property is Grade II Listed and within the conservation area. The neighbouring property has a pedestrian right of way across the rear of the property.

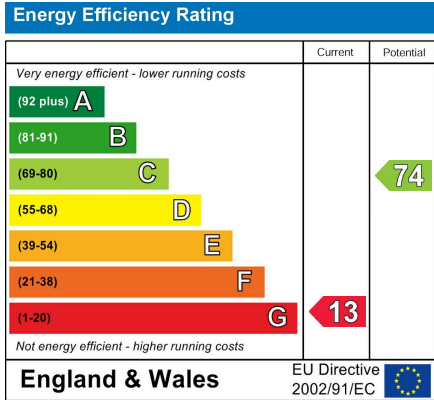
Floor Plan
