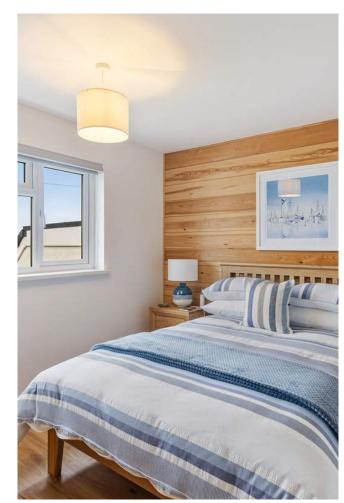

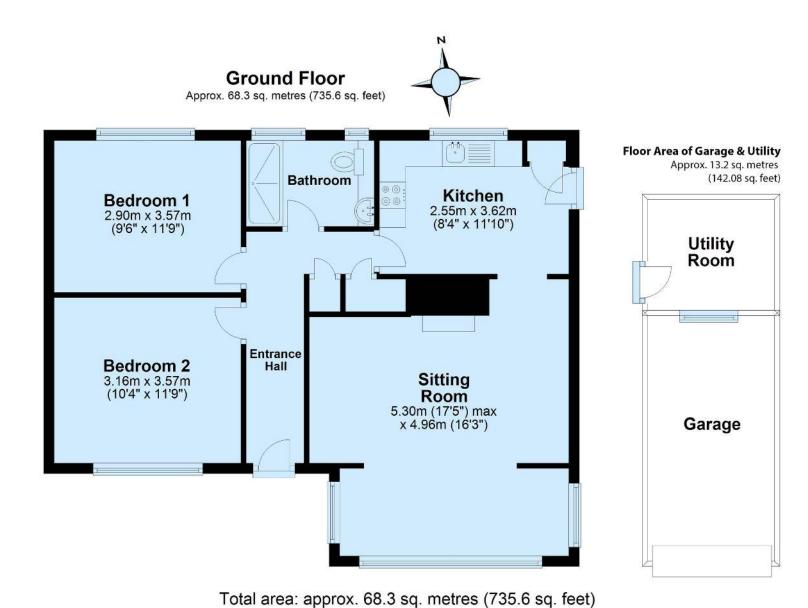








# Floor Plans
