Tides Meet is a charming semi-detached bungalow boasting an exceptional coastal outlook. Perfectly positioned along Marine Drive in the sought-after village of Bigbury-on-Sea, the property offers uninterrupted panoramic views across the coastline and towards the iconic Burgh Island. This three bedroom property does require a degree of updating, offered with no onward chain, set within front and rear gardens, off street parking and a single garage. A wonderful opportunity to acquire a special coastal retreat with breathtaking views.

ACCOMMODATION

An entrance porch leads into the inner hallway, which connects the principal rooms of this unique coastal home. Tides Meet offers a well-balanced layout comprising three bedrooms, a spacious sitting/dining room, kitchen, and shower room. The sitting/dining room enjoys a triple aspect, with a large front-facing picture window perfectly framing the breathtaking sea and Burgh Island views. A rear window offers a tranquil outlook over the garden, creating a light-filled and relaxing space to unwind or entertain. The kitchen, also benefitting from the spectacular coastal outlook through its front aspect window, is fitted with a range of matching wall and base units. It includes an integrated electric oven and hob, space for appliances, and a breakfast bar. The Shower room is arranged with a coner shower unit, wc and basin. All three bedrooms are positioned at the rear of the property, enjoying peaceful garden views.

Externally, an attached single garage offers secure parking or storage, and includes a utility store to the rear, with convenient access from the garden.

OUTSIDE

A drive leading to the property provides off street parking, alongside a generous are of lawn and access around the property to the rear. The rear garden has steps leading up from the property, predominantly laid to lawn, with bordering shrubs.

LOCATION

Bigbury-on-Sea is a beautiful coastal village renowned for its large expanse of sandy beach, with a causeway formed at low tide leading to the iconic Burgh Island. Nearby there is a good range of amenities and shops in the market town of Kingsbridge and the Georgian town of Modbury. Wonderful cliff top and coastal walks as well as other beaches and coves can be found nearby, along with sailing at Salcombe and Newton

Directions

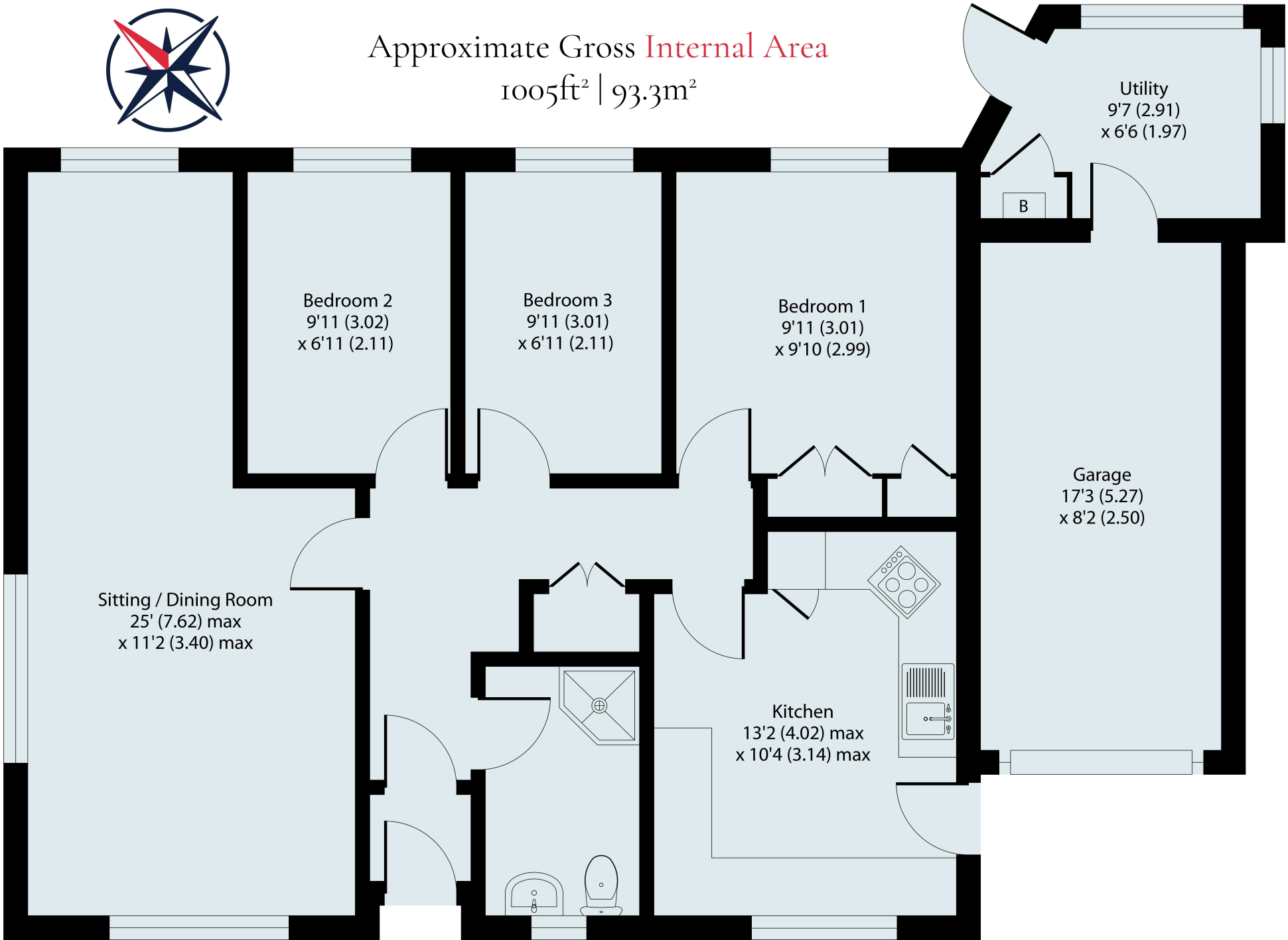
