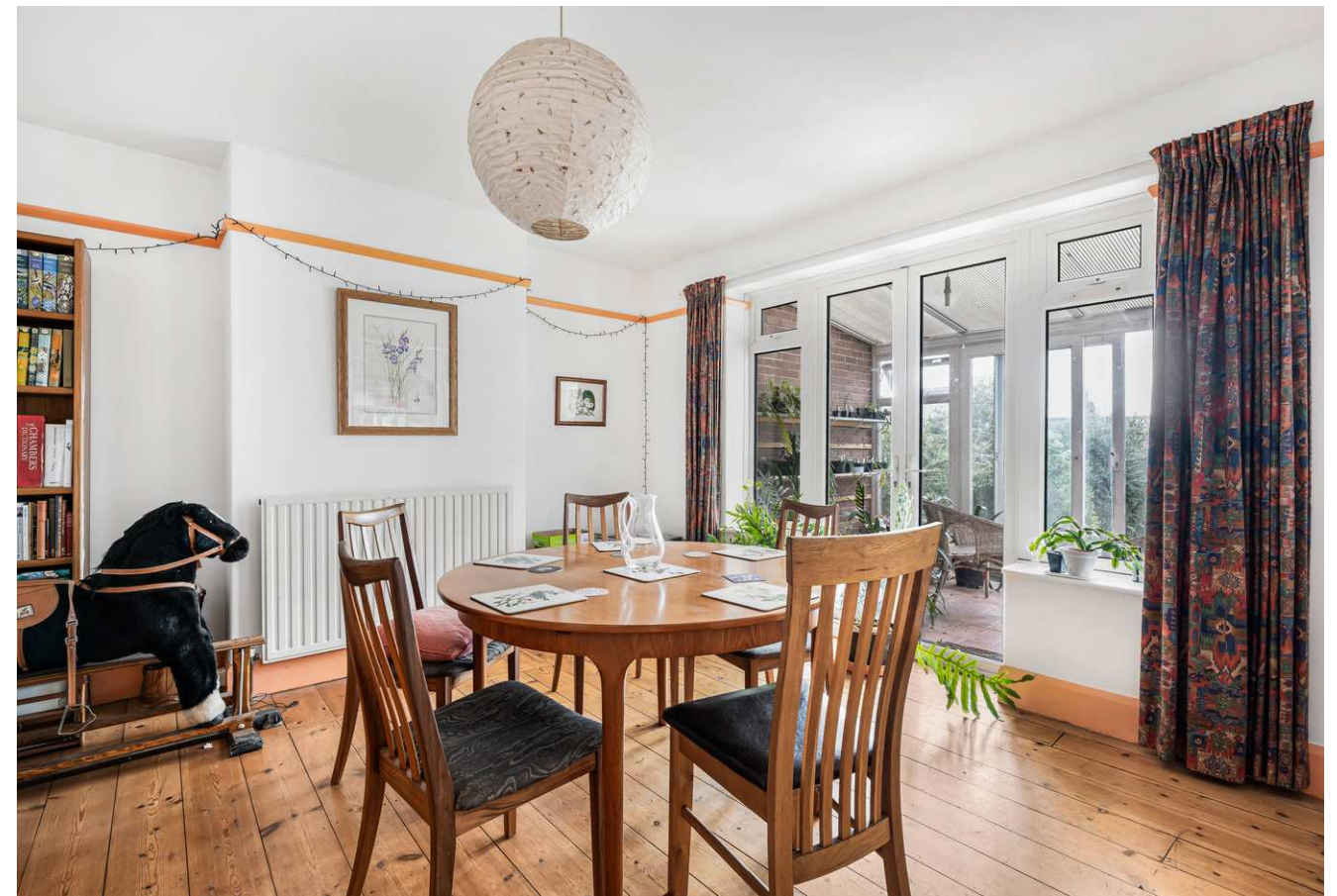
PENTAMAR

Situated in an excellent location within walking distance of the town centre and amenities, a semi-detached family home with front and rear gardens, three good-sized bedrooms and driveway parking. Offered to the market with no onward chain.

The accommodation comprises side entrance porchway opening to the entrance hall, where there is an opening to a useful study and cloakroom. There is a large open plan sitting/dining room leading through to the conservatory and out to the front garden. To the rear of the ground floor is the kitchen which gives access to the rear garden and driveway parking. To the first floor are three good-sized bedrooms, all with storage cupboards. A family bathroom and separate WC complete the accommodation.

The front garden is mostly laid to lawn with mature shrubs and trees offering privacy, a path leads to the side entrance and around to the rear garden which has a section of lawn leading to a gravelled area with greenhouse and space to grow vegetables, beyond here is the driveway parking.

Totnes town is the commercial centre for the South Hams. This part of Devon is renowned for its outstanding natural beauty with Dartmoor National Park ten miles to the north and stunning beaches and coastline ten miles to the south. The bustling medieval market town has a mainline railway station giving direct connections to London Paddington with easy connection to St Pancras for Eurostar. There is also excellent access to the A38 Devon Expressway, linking Plymouth and Exeter where it joins the M5. Schooling in the area is excellent with a number of well-regarded primary and secondary schools. Totnes also boasts a thriving market as well as a good selection of shops, supermarkets, restaurants and inns.

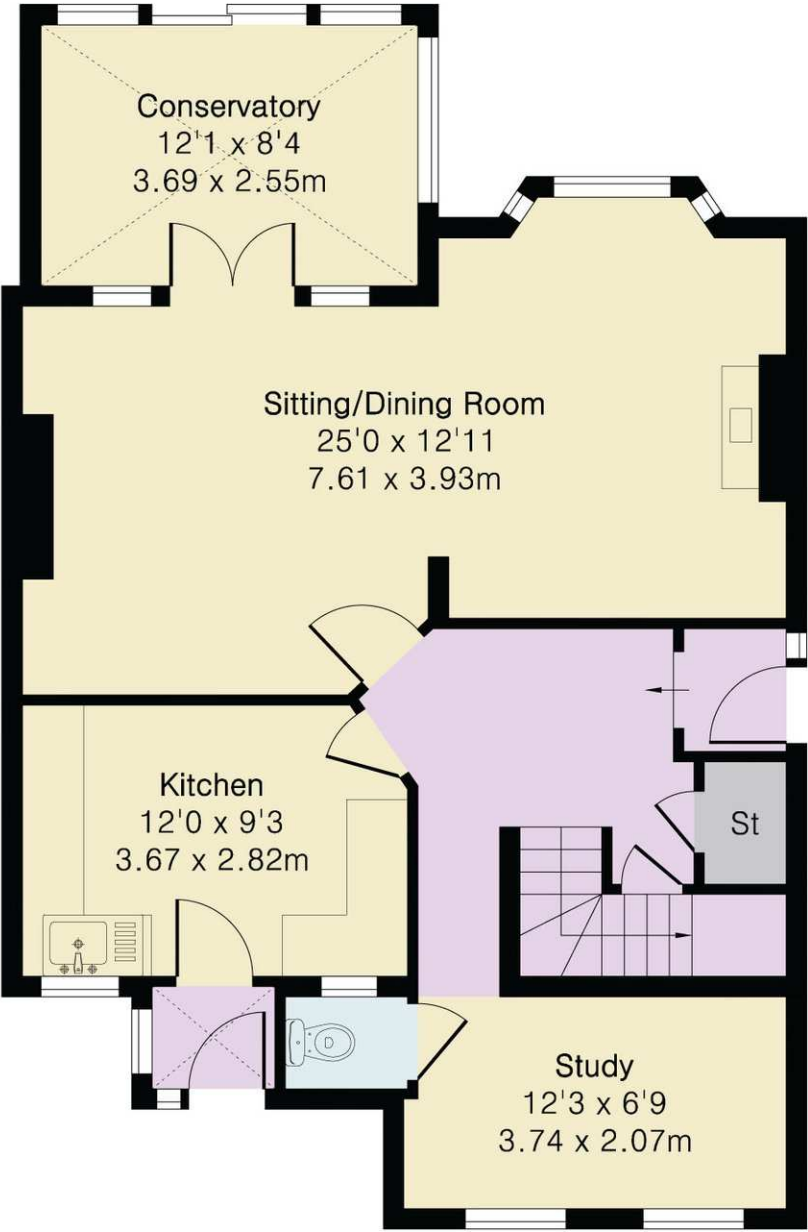

FLOORPLAN

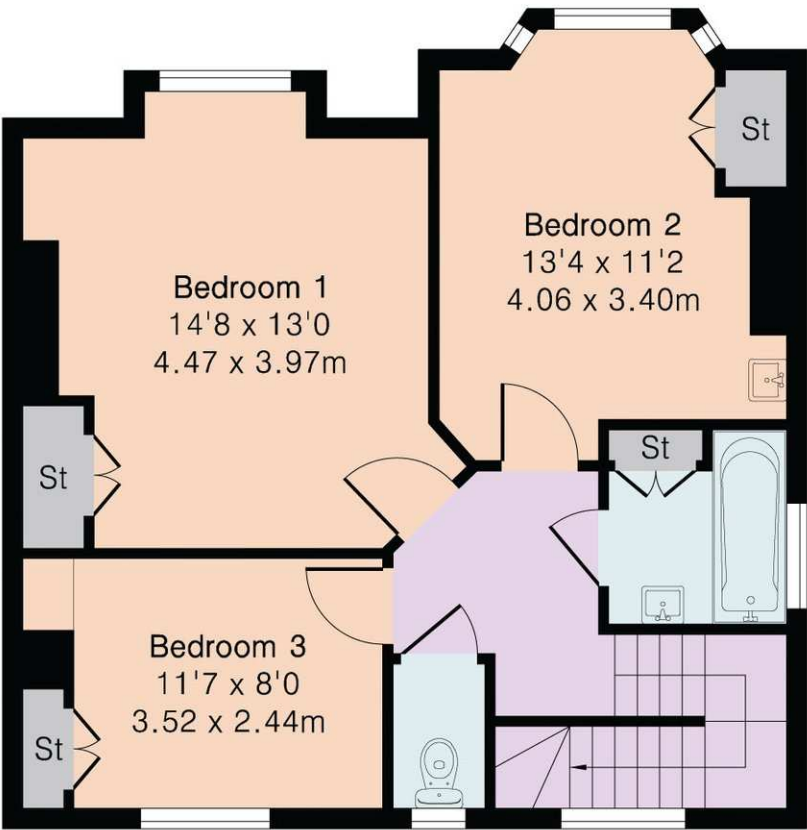
