The Property: The ground floor consists of living room, newly fitted kitchen with an integrated dishwasher, electric hob and oven, dining room and WC. Upstairs there are two bedrooms. The bathroom features tasteful décor with a double shower and double ended bath. Note: The open fire is not to be used and is visual only.

Outside: Spacious garden to the side and rear of the property with shed, outbuildings, off road parking.

Services: Property is connected to mains electricity, mains water, private drainage shared and oil fired central heating.

Terms of the Tenancy: The property will be let on an Assured Shorthold Tenancy for an initial fixed term of a minimum of 12 months.

Rent: The rent, exclusive of all other outgoings and Council Tax will be £995 per calendar month payable monthly in advance by standing order.

Tenancy Deposit: A Tenancy Deposit of five weeks rent will be payable to the Agent on signing the tenancy agreement. This will be held in a government approved deposit scheme by either the Landlord or the Agent.

Tenancy Agreement: A draft copy of the tenancy agreement will be available for inspection at the Agent's offices.


