Directions: Travelling along the A143 towards Bury St Edmunds from Diss, as you come into Wortham village take the left onto Mellis Road and then the second left into Cherry Tree Close. The property can be found immediately on your left hand side.

The Property: The property consists of an entrance hall, kitchen, spacious living room which leads out into the garden, WC and dining room on the ground floor. Upstairs there are two double bedrooms and a family bathroom.

Outside: The property has an enclosed rear garden mainly laid to lawn with a large patio area. Parking for two cars and a garage.

Services: The property benefits from mains electricity, with an air source heat pump to provide underfloor heating and solar thermal water heating. Mains water and a sewage treatment plant for the estate, the cost of maintenance for which is included in the rent.

Terms of the Tenancy: The property will be let on an Assured Shorthold Tenancy for an initial fixed term of a minimum of 12 months.

Rent: The rent, exclusive of all other outgoings and Council Tax will be £895.00 per calendar month payable monthly in advance by standing order.

Tenancy Deposit: A Tenancy Deposit of five weeks rent will be payable to the Agent on signing the tenancy agreement. This will be held in a government approved deposit scheme by either the Landlord or the Agent.

Tenancy Agreement: A draft copy of the tenancy agreement will be available for inspection at the Agent's offices.

The Holding Deposit is refundable if:


- The landlord accepts your application for the tenancy, in which case this will be carried forward towards the Tenancy Deposit and registered with TDS.
