Directions: From Diss follow the A140 towards Ipswich. Take a left hand turn towards Eye at the junction opposite the Brome Grange. Take the first left into Brome Street and follow this road into Oakley. The Old Post Office will be found on the right hand side.

The Property: Consists of an entrance hall leading to the living room and dinning room with wood burning stove. From the dining room a door leads into the family bathroom. There is also a separate WC and spacious kitchen/breakfast room. Upstairs there are three bedrooms with period features.

Outside: There is a large garden to the side and rear. Parking area. Storage shed.
















Ground Floor
