Reception hall, downstairs w.c, kitchen, living room, dining room, two bedrooms, bathroom, enclosed garden, driveway parking. Gas boiler serving radiators, double glazing to windows as specified.

Front door with inset obscure glazed double glazed panels, panelled radiator, staircase leading to first floor accommodation.

DOWNSTAIRS W.C (SIDE)

W.C. with low level cistern, pedestal wash-hand basin with tiled splashback, tile finish to floor, panelled radiator, double glazed window to front elevation.

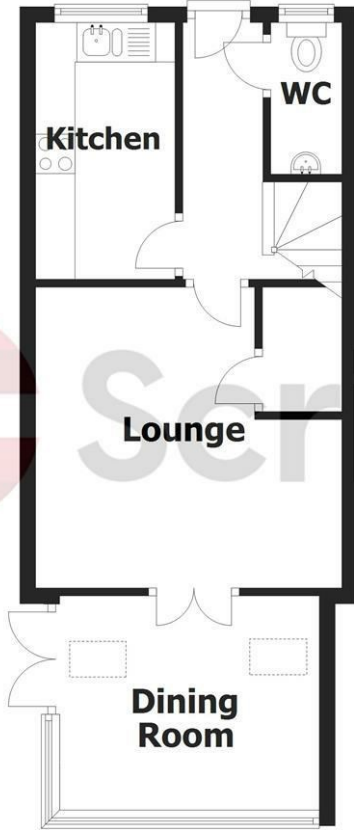

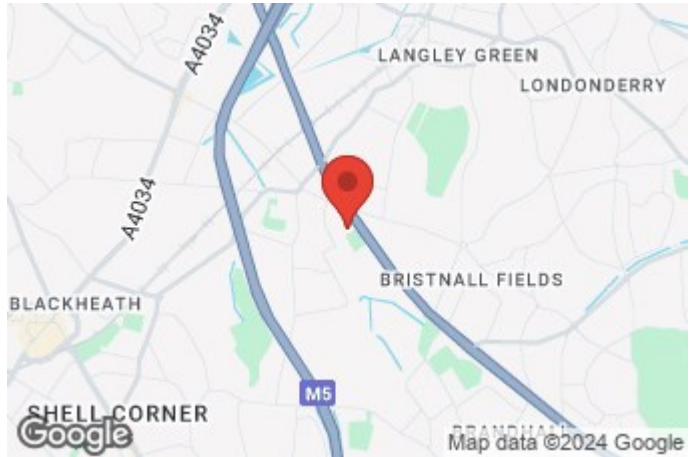
Ground Floor
