Situated in a cul-de-sac location is this tastefully presented two bedroom semi-detached house. The property benefits from two reception rooms, downstairs w.c. and re-fitted shower room.

Accommodation comprises: Reception hall, downstairs W.C, kitchen, lounge, dining room, landing, two bedrooms, refitted shower room, rear garden, garage/store. Gas boiler serving radiators. Double glazing as specified.

#### RECEPTION HALL (Inner)

Composite front door with obscure double glazed panel, recessed spot lights to ceiling, wood effect floor finish, coving to ceiling, panel radiator. USEFUL STORAGE CUPBOARD (opening off under stairs). Staircase off to first floor landing with hand rail. Door opening onto former garage/inner store and archway onto kitchen.

#### GROUND FLOOR W.C.

Vinyl floor finish, wall mounted electric heater, w.c. with push button flush, toilet roll holder, towel holder, wash hand basin with vanity unit, mixer tap, mirrored cabinet to wall.

#### KITCHEN (Rear) 2.29m x 2.86m

Recessed spot lights to ceiling, double glazed double doors and double glazed windows onto rear garden, wood effect floor finish. The kitchen is fitted with a range of base units with cupboards and drawers, complementary work tops, bowl and half single drainer steel sink with mixer tap (incorporating instant boiling water function), storage cupboards at high level, recess for fridge freezer, plumbing for washing machine and dishwasher, 'Neff' double oven, 'four' ring electric induction hob, cooker hood above, wall mounted storage cupboards at high level.

#### LOUNGE (Rear) 3.47m (3.12m) x 4.40m

Gas fire with fire surround, coving to ceiling, double glazed sliding patio door onto rear garden, panel radiator.

#### DINING ROOM (Front) 2.73m x 3.53m

Coving to ceiling, double glazed window to front, panel radiator.

Staircase from ground floor reception hall with double glazed window to side.

#### FIRST FLOOR LANDING (Inner)

Access to roof space, doors off.

#### BEDROOM ONE (Front) 3.25m max x 3.11m plus storage recess

Double glazed window, panel radiator, fitted bedroom furniture comprising wardrobes with over bed storage, display shelving and bedside tables.

Opening onto STORAGE AREA with panel radiator, recessed spot lights, dressing table with a range of cupboards and work top, light (restricted head room).

#### BEDROOM TWO (Rear) 3.43m x 3.48m max and 3.10m min (measurements taken into wardrobe).

Coving to ceiling, ceiling light with fan, panel radiator, fitted

wardrobe with sliding mirrored doors, double glazed window overlooking rear garden.

#### RE FITTED SHOWER ROOM (Rear)

Recessed spot light to ceiling, wood effect floor, w.c. with push button flush, panel radiator, obscure double glazed window, wash hand basin with vanity unit, mixer tap, mirror to wall with glass shelf, walk in shower cubicle with shower screen, dual shower fitting, walls tiled to full height.

#### REAR GARDEN

Comprising, patio area onto shaped lawn, borders filled with shrubs and plants, further patio area to top of garden with raised bed, garden shed. Rear garden store with space for condenser dryer.






## Ground Floor
