Panel radiator, staircase with handrail leading off to first floor landing. Door onto:

THROUGH LIVING ROOM (Front/Rear)

Double glazed bay window and double glazed double doors onto rear garden. Two panel radiators, wood effect floor finish, coving to ceiling. Gas fire with fire surround.

KITCHEN (Rear) 1.96m x 3.12m plus door recess. Double glazed window, recessed spot lights to ceiling, wall mounted 'Ideal' boiler, base units with cupboards and drawers, work tops, tiled splashbacks, single bowl single drainer sink with mixer tap, wall mounted storage cupboards at high level, space and plumbing for 'slimline' dishwasher and washing machine, space for cooker. Door onto side entry.

BEDROOM TWO (Rear) 4.03m x 2.93m max Double glazed window, panel radiator with radiator cover.

BEDROOM THREE (Front) 3.06m max x 1.97m max Double glazed window, panel radiator.

SEPARATE W.C. (Side)

Obscure double glazed window, w.c. with low level flush,

BATHROOM (Rear) 1.93m x 1.68m (2.14m max) Obscure double glazed window, panel radiator, pedestal wash hand basin, panel bath, electric shower, walls to bath part tiled.


