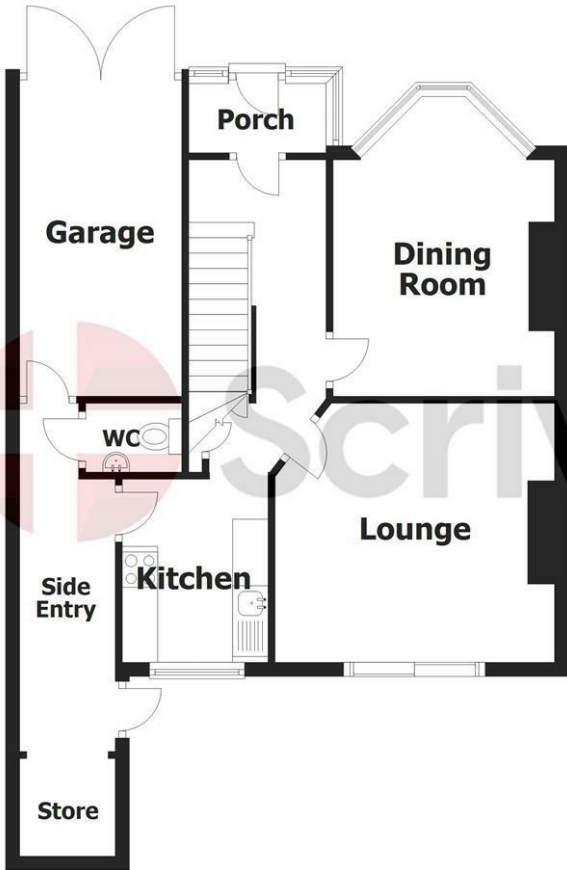

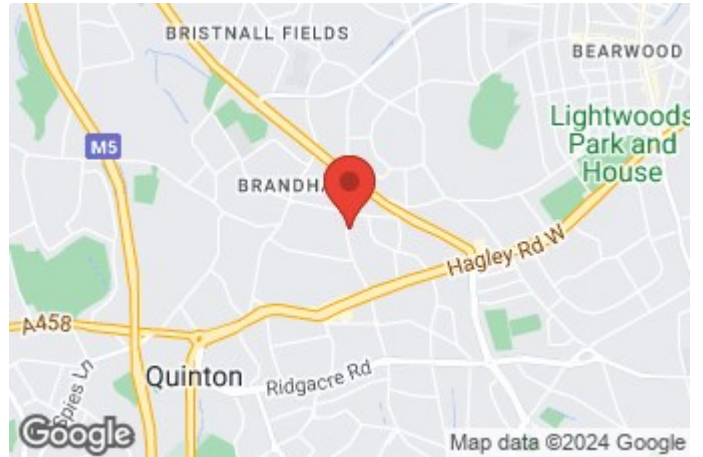
**Ground Floor**
