They have also identified signs of woodboring beetle and wet rot to the floor timbers with a further additional cost to repair estimated in the region of £2000.00 -£2500.00 plus VAT. 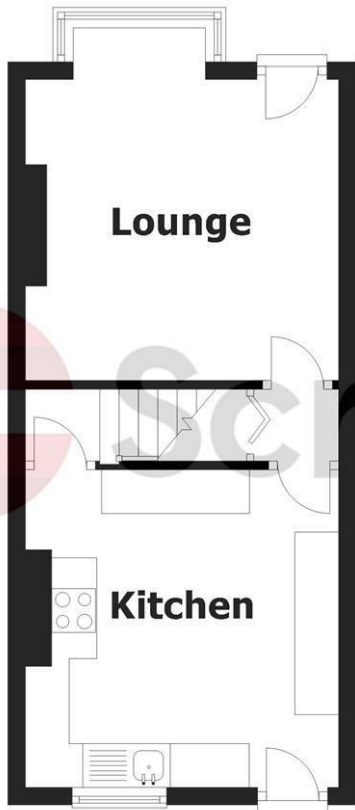

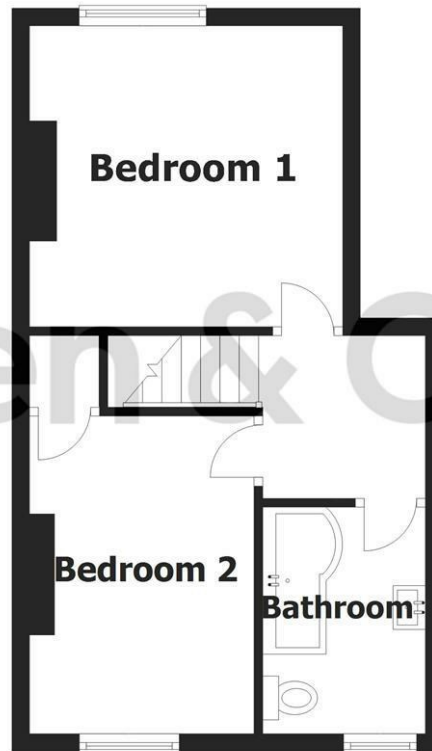
