The Entrance Hallway (1.3m x 3.4m) has a uPVC double glazed external door and doors to the reception rooms, shower room and two bedrooms. The Shower Room (2.6m x 1.4m) has a shower unit, W/C, pedestal sink and Airing Cupboard. Bedroom One (4m x 2.8m) has built in storage and looks out onto the rear garden. Bedroom Two (2.8m x 2.4m) also has built in storage units.

The Living/ Dining Room (3.9m x 3.5m) has a Dimplex electric heater, space for a dining table and looks out onto the front elevation with a door to the: Kitchen (3.5m x 2.5m) with fitted wall and base units, stainless steel sink and drainer unit, Stoves oven and hob, space for washing machine and external uPVC double glazed door to the rear garden.











Ground Floor Floor Size: 50.1 m², 539.0 ft²
