
Situated in a convenient location in close walking distance of Dalton town centre, this two bedroom mid terrace property is an ideal renovation and upgrading project.

The accommodation comprises; An external front door to the Entrance Porch (1.0m x 0.8m) and internal door to the Living Room (3.6m x 3.3m) with an uPVC double glazed window to the front elevation, window seat, electric fireplace with tiled surround and a built in storage cupboard. Door to:

Dining Room (3.0m x 2.8m) with an uPVC double glazed window to the rear aspect, electric fire, understairs storage cupboard, door to the stairs to the first floor, door to the:

Kitchen (2.0m x 1.7m) with basic wall and base units with work surfaces over, two stainless steel sinks, uPVC double glazed window, lino flooring.



Rear Hallway (2.2m x 0.8m) with an external door to the rear yard and door to the:

Ground Floor Shower Room (2.1m x 1.6m) with low level W/C, pedestal sink, corner shower unit, part white tiled walls, frosted uPVC double glazed window and lino flooring.
